## City Bag Fee - Kevin Anstett

For those of you who have not heard, the City Council of Fort Collins recently passed an ordinance requiring all retailers to charge a \$0.05 fee on all disposable bags. Hundreds of people contacted their council members through email, phone calls, and face to face at meetings, however, despite public outcry that the community did not support government regulation of businesses, the ordinance passed with a 5-2 vote. The ordinance was also changed at final reading from the original proposal that would have only applied to stores over 5,000 square feet. This new regulation applies all retailers regardless of size, and many of the small, local businesses are not equipped to track bag "purchases".

The general public and numerous business owners have banded together to form a group called Citizens for Recycling Choices to petition for the repeal of this ordinance. On Monday,  $\int$  eptember  $29^{th}$ , a group of volunteers turned in 4,133 signatures to the City Clerk. We will find out on October  $6^{th}$  if enough valid signatures were collected to either give the council the opportunity to repeal the ordinance, or have it go to public vote. There will be another City Council meeting on October  $21^{st}$  to discuss this issue.

It is my goal as a REALTOR and a business owner, to help keep Fort Collins a place that has a reasonable cost of living, a city that is friendly to small businesses, and a community that encourages growth and development, so I have been very vocal and involved in this issue since day one.
